- Current focus on External Relations

- Dubai office will also host staff temporarily assigned from other departments
  - Building relationships with our members in the region



### RIPE NCC External Relations

- External Relations (ER) section formed in 2010
  - Focused on RIPE NCC engagement with all external stakeholders
    - Members, community, government, regulators, law enforcement
- ER Mark II (2014)
  - Expanding to better serve stakeholders beyond Europe
  - Additional staff based in Dubai and Moscow
  - Drawing on technical, communications and policy expertise








  - Engaging directly with non-member regional stakeholders, including governments, regulators and law enforcement
  - Building on existing regional programs, like the MENOG IPv6 Roadshow and RIPE NCC training efforts...



### **Training**

- MENOG IPv6 Roadshow entirely revised

  - Working on trainer notes and instructions
  - Building our team of community trainers
  - Working with public sector partners throughout the region
- New two-day IPv6 technical training for RIPE NCC Members to be launched soon

### **Recent Developments**

- Evolution of IANA function oversight
  - Multi-stakeholder process of developing model for going forward
  - US Gov't to oversight role to be removed
  - Proposes to replace NTIA role with a multi-stakeholder model - not led by gov't or inter-gov't org
  - Facilitated by ICANN, but not an ICANN process all stakeholders need to have their say!

# **Recent Developments**

- Role of governments and international organisations
  - Ongoing discussions in the International Telecommunications Union (ITU)
    - World Telecommunications Development Conference currently underway in Dubai
    - Plenipotentiary 2014 in Busan, South Korea, October
  - United Nations



- Provide accurate, factual information
  - How the Internet operates
  - How bottom-up policy development works
  - Statistics on IP address registration, IPv6 adoption
- Defend the open, multi-stakeholder model of Internet governance
- Ensure that the RIPE (and technical) communities are effectively represented in all discussions
- Ensure that our community is well-informed of Internet governance developments



### **Internet Governance Forum**

- RIPE NCC regards the IGF as primary venue for Internet governance discussions
  - A vital part of the multi-stakeholder Internet governance model
- Paul Rendek a member of the Multi-stakeholder Advisory Group (MAG)
- IGF 2014 takes place in Istanbul, Turkey
  - 1-5 September
  - Call for workshop proposals now open!

  - National IGF events across the RIPE NCC service region



- Third Arab IGF will take place in 2014

- Important opportunity to discuss regional concerns, including:
  - IPv6 adoption and capacity building
  - IPv4 trading developments
  - Security
- A means to channel regional concerns into global Internet governance debates
