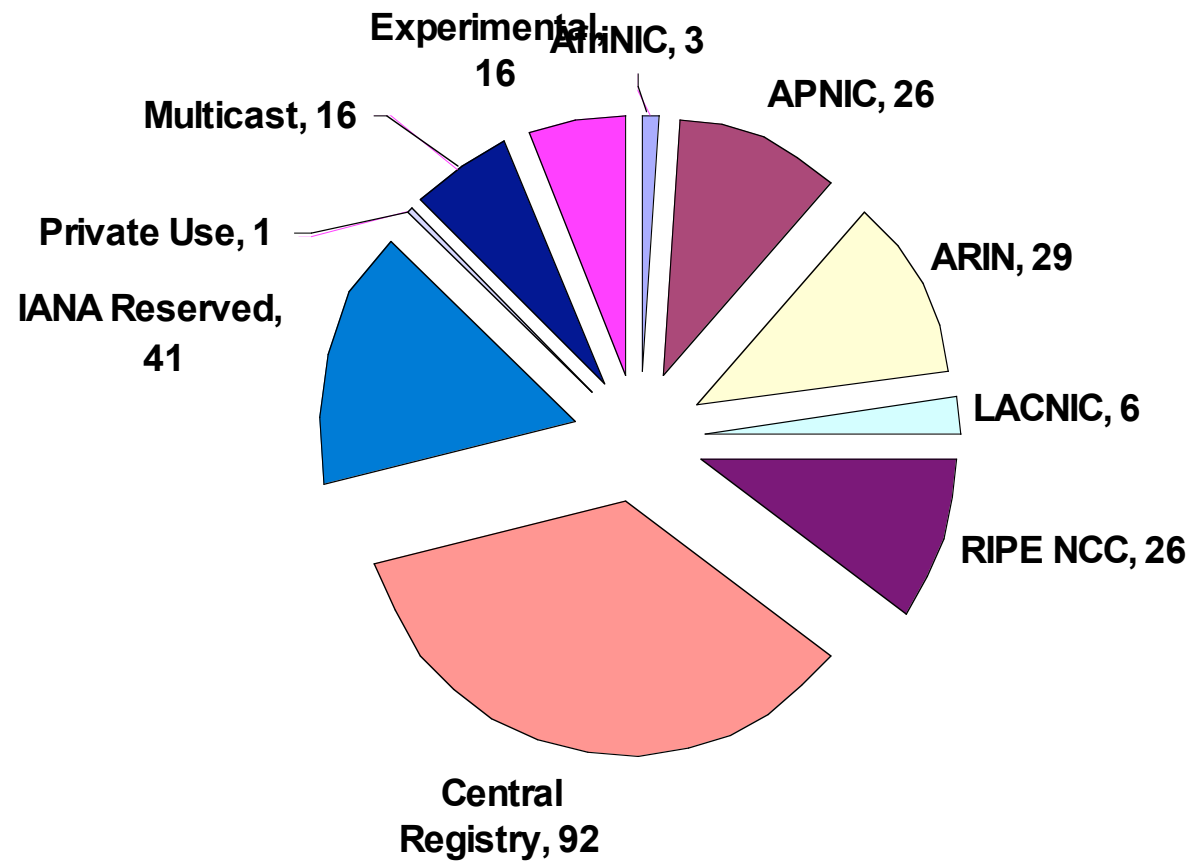

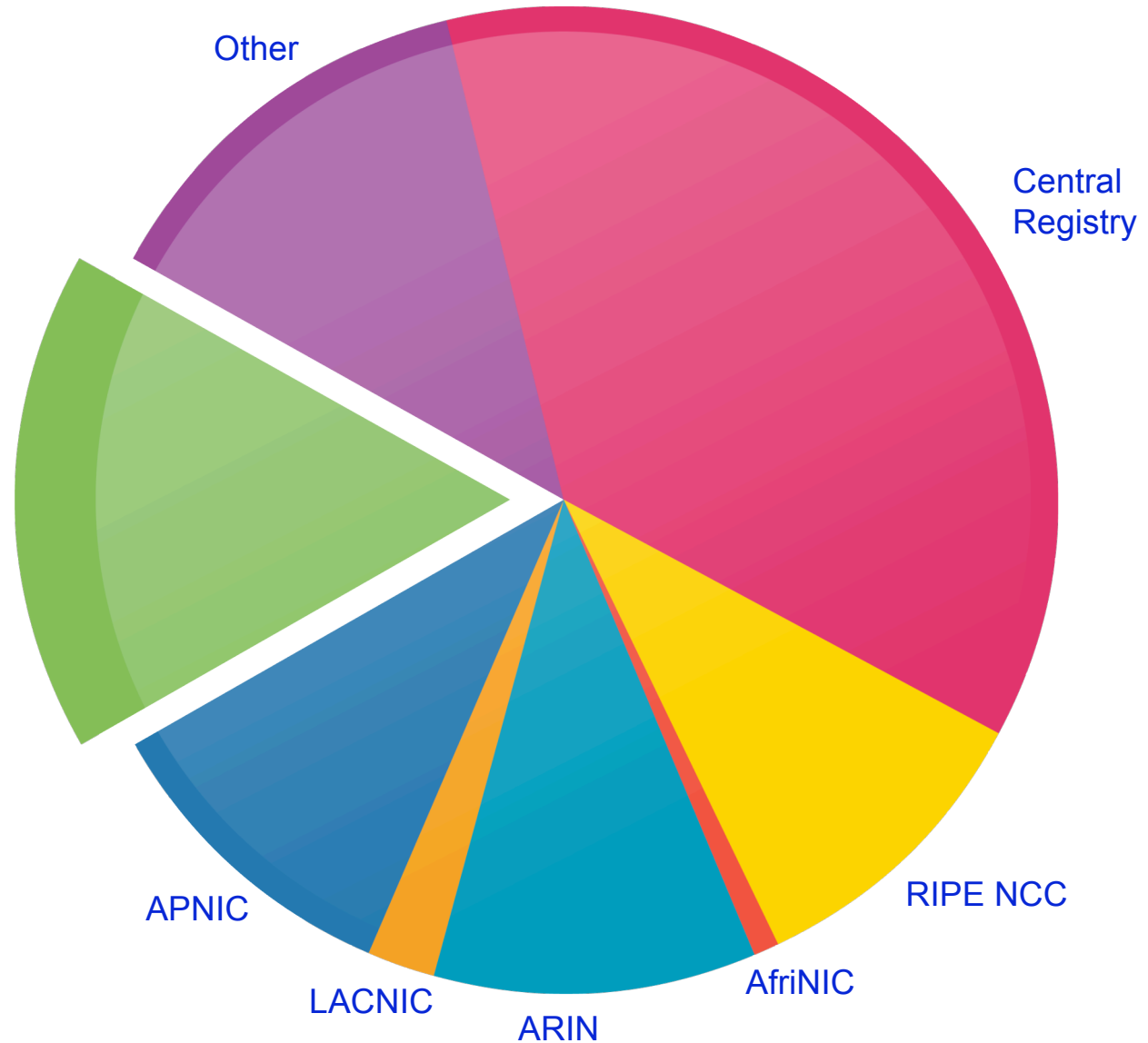
IPv4 Global Distribution





IPv4 Global Usage - Another view

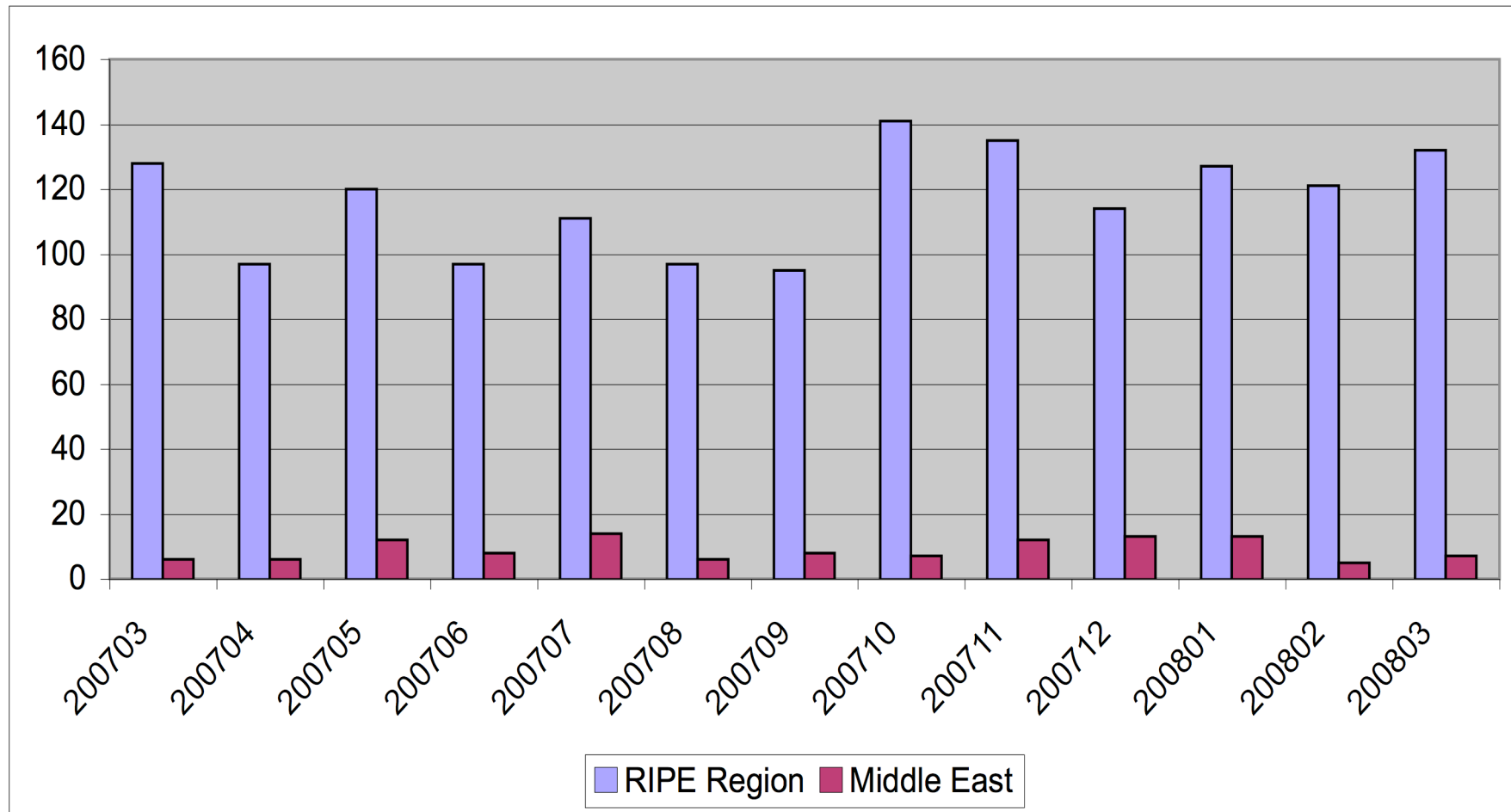

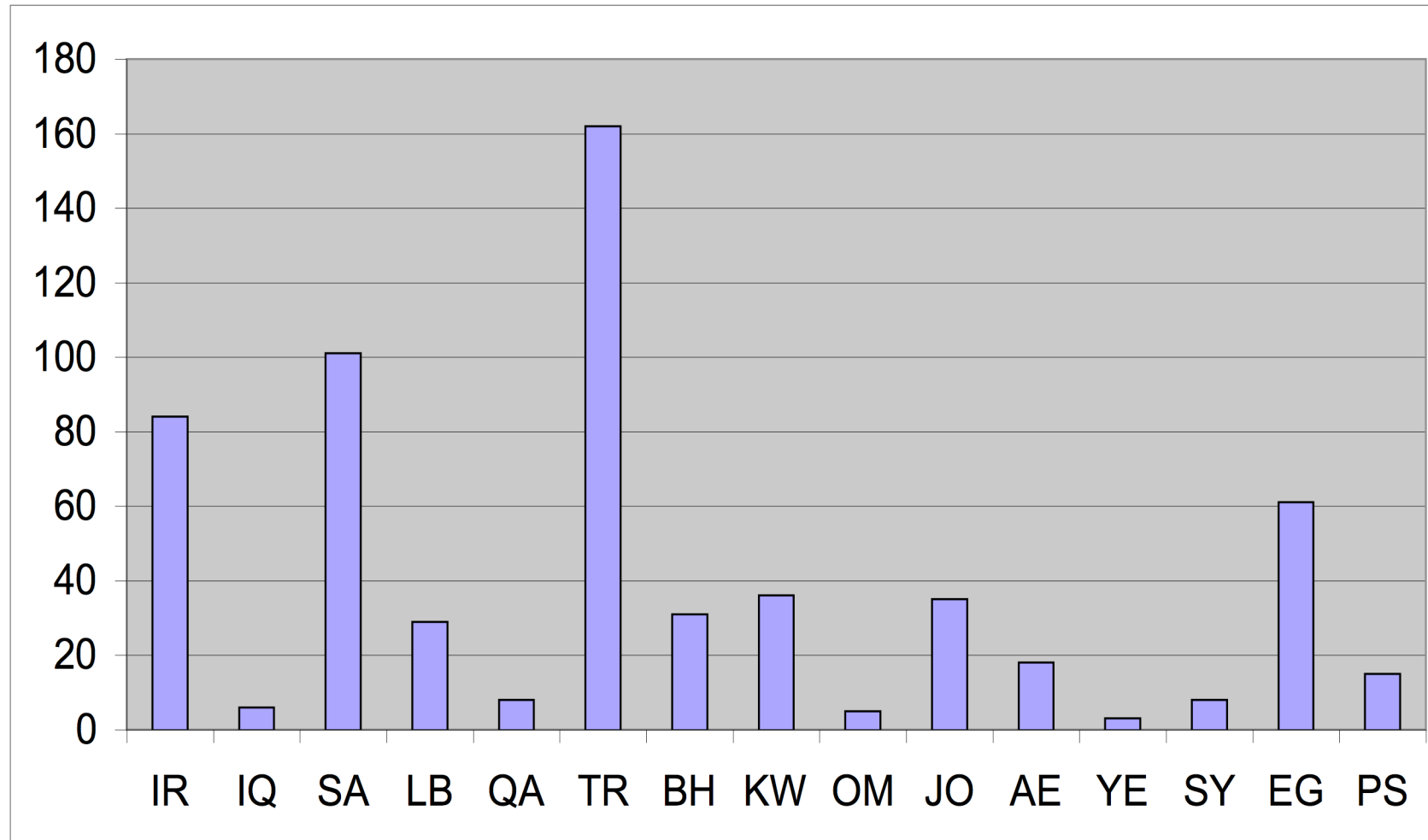


RIPE IPv4 Allocations (Last 12 Months)



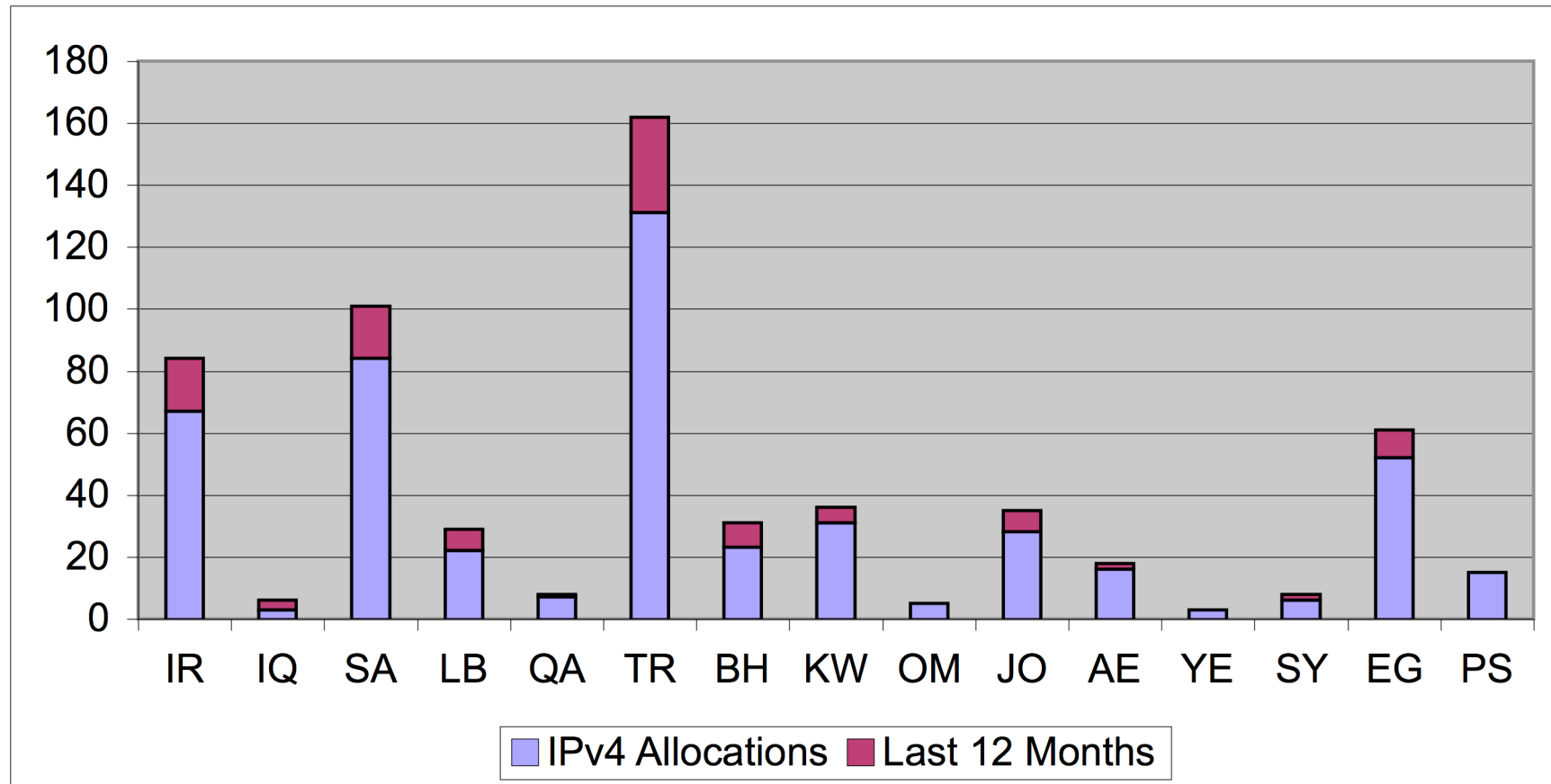


IPv4 Allocations in the Middle East



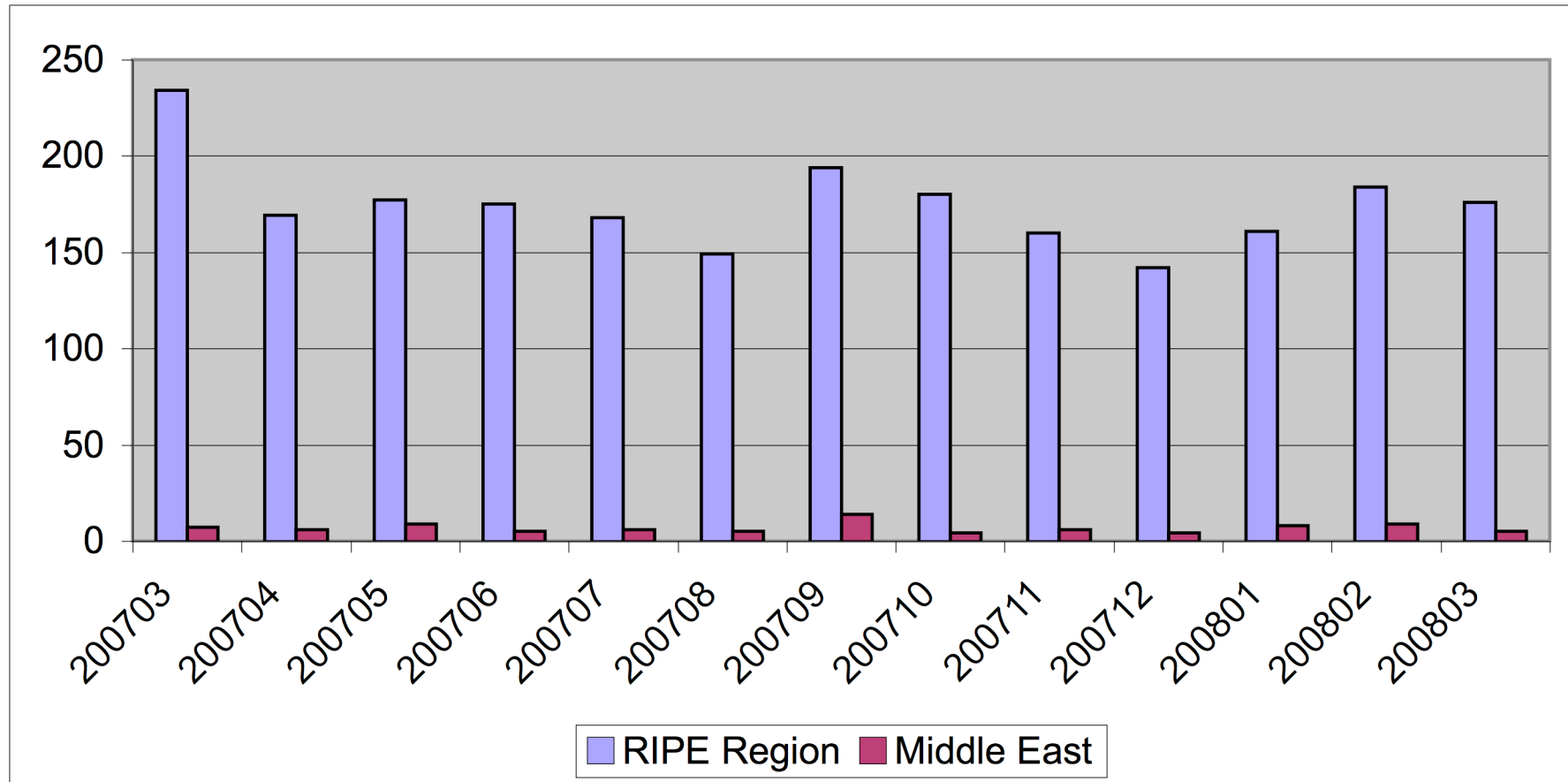


IPv4 Allocations in the Middle East



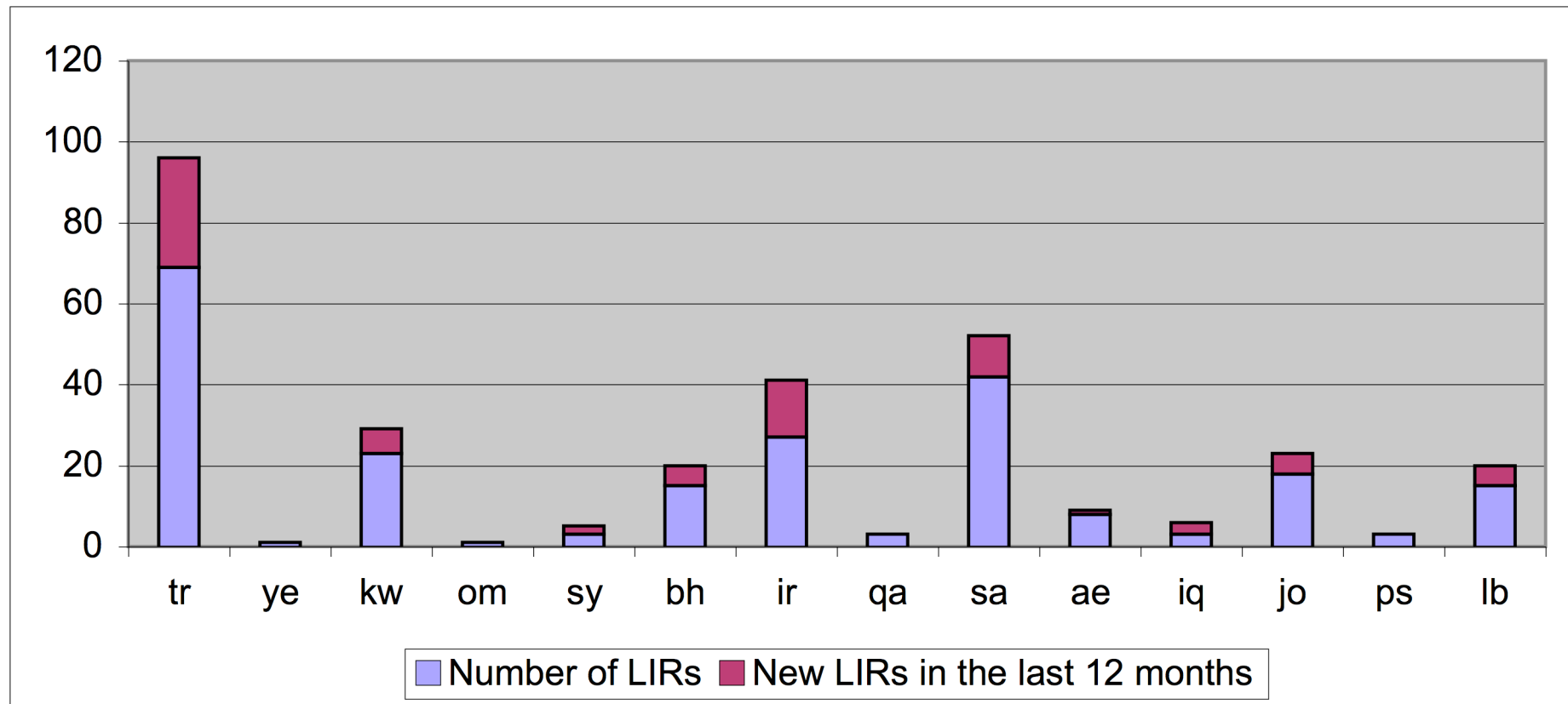


PI Assignments (Last 12 months)



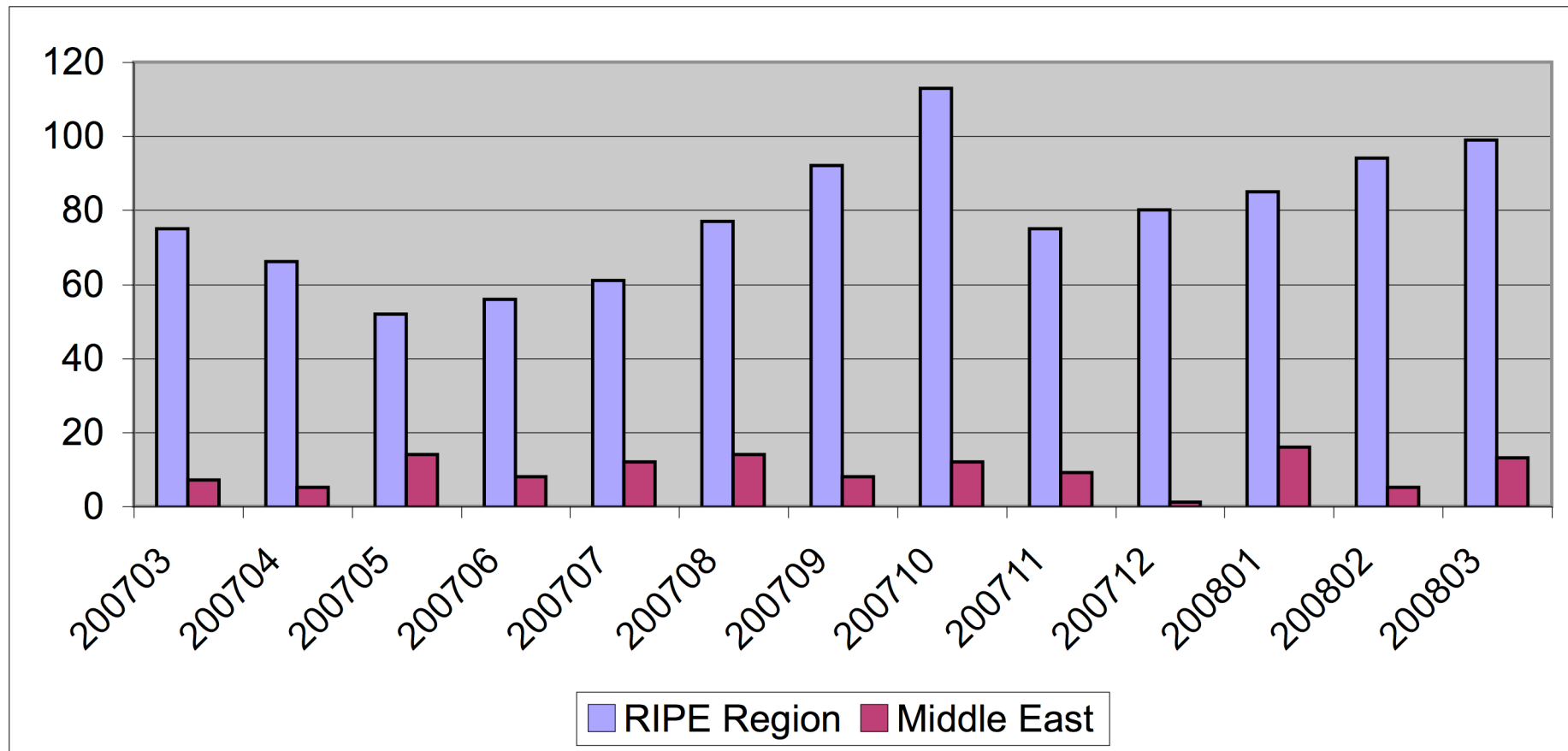


Number of LIRs in the Middle East

RIPE Policy Update

- IPv6 related update --> see the other presentation
- 2007-04, IANA Policy for Allocation of ASN Blocks to RIRs
 - ALL regions accepted
 - In ASO-AC review and then ICANN ratification expected
 - Main point: Document the practice



RIPE Policy Update

- 2007-01, Direct Internet Resource Assignments to End Users from the RIPE NCC
 - End Users contracts with a “sponsoring LIR” or the RIPE NCC
 - All direct assignments included (PI, ASN, Anycasting, IXP)
 - Works retroactively (ERX and Legacy)
 - In Last Call (until 5 May)
 - Main point: Responsible stewardship of resources



RIPE Policy Update

- 2007-08, Enabling Methods for Reallocation of IPv4 Resources
 - Allows transfers between LIRs
 - No prior RIPE NCC approval needed
 - Blocks must be free
 - Min Allocation size
 - A recipient LIR cannot transfer within 24 months
 - Permanent or non-permanent
 - In Review Phase (just ended)



RIPE Policy Update (also World Wide)

- 2008-03, Global Policy for the Allocation of the Remaining IPv4 Address Space
 - Resulting 3 previous proposals
 - Author team across regions (15 people)
 - Distribute the last 5 /8s evenly among RIRs (N=1)
 - Main point:
 - Less pain (if any) in reaching the end of IPv4 free pool
 - Each region then can define a policy on how to distribute the last piece(s) of allocations which best matches their situation
 - Opposition based on “demonstration of need” principle



RIPE Policy Update (Also World Wide)

- 2007-09, Cooperative distribution of the end of the IPv4 free pool
 - Proposed to be in effect after the IANA pool runs out
 - A source RIR is set
 - Others request like LIRs from the source
